Swap Meet Exhibitor Space:

Each Swap Meet Exhibitor space includes:

Swap Meet Exhibitor Space Location:

Exhibitor not checked in and table set up by that time will forfeit their table space with no refund. <u>Badges</u>:

All Swap Meet Exhibitors must have a valid Animé Los Angeles badge for the day(s) they wish to exhibit.

Configuration of Booth Space:

Swap Meet Exhibitor can configure its Exhibitor Space, if Exhibitor property and displays do not extend and intrude beyond the assigned space or violate any other applicable provision of this contract. Swap Meet Exhibitor will keep its Exhibitor Space clean and is responsible for any damage to its Exhibitor Space. Swap Meet Exhibitors shall construct its exhibits to comply with the Americans with Disabilities Act. Additional Costs: Any Additional Costs incurred by Animé Los Angeles from the Marriott Hotel and/or decorator for any Swap Meet Exhibitor requests will be passed through to the Exhibitor and billed immediately. All such amounts are due immediately upon receipt of invoice.
